
### **Esox Schmeesox**

From an abundance of young-of-theyear on spawning sites to a few senescent individuals, the Southern Ontario Chapter may well have one of the healthiest populations of esocid experts in North America. Up to now this newsletter has been lacking information on current esocid developments. However, this is now resolved as the voracious pikes are taking their due place of respect.

A North Central Division Esocid Technical Committee was formed the recent Midwest Fish and Wildlife Conference in Des Moines, Iowa. This organizational meeting resulted in forming a mission statement as follows: (1) to encourage and coordinate research leading to the development of functional management strategies toward the use of esocid populations, (2) to advance the knowledge of esocid ecology, (3) to improve culture techniques, and (4) to provide a forum in which pertinent data and technologies can be exchanged within the scientific community and among user groups. It was agreed that a mid-year meeting would be held in LaCrosse, Wisconsin on July 14, 1992. The focus of this meeting was to provide a foundation for the committee

in terms of esocid management and current research and expertise. Each chapter president was requested to select a representative within their chapter to compile information for the July meeting.


Coincidental with the formation of the new NCD Esocid Technical Committee. Lebeau's (1992) Ph.D. thesis on historical ecology and phylogenetic systematics of large esocids has been accepted at the University of Toronto. Implications from this study have significant repercussions on the future socio-economics, fish culture, management, and research of North American esocids. A new species is described, which is most closely related to muskellunge, and has the proposed official vernacular name maskinonge. The description of the new species of Esox is presently under review for publication in Copeia, and so far has received positive criticisms. Thus, the subject of the present assignment will be to provide a Management Summary and review recent and current research studies throughout Ontario. Today's management objectives and problems, population status and abundance, as well as regulations will be reviewed for pike,



muskellunge, as well as maskinonge. A new proposal suggesting important modifications to esocid management policies and fishing regulations is in sight.


### Calendar

## Esocid Technical Committee Formed

An Esocid Technical Committee was formed at the recent Midwest Fish and Wildlife Conference held in Des Moines, Iowa. The committees's mission is to encourage and coordinate research of esocids and to provide a forum for exchange of pertinent data and technologies within North Central Division (NCD) chapters of the AFS. To kick off the new committee, a symposium on Northern Pike ecology and management was held which included eight technical papers on pike research in our area.

The Esocid Technical Committee will hold its next meeting in July at LaCrosse, WI. Discussions for this mid-year meeting will center around historical and current esocid management strategies, and ongoing research within the NCD. The purpose of this meeting is to bring together management philosophies and research directions of NCD states and provinces. ### Fisheries Education in Canada

A newly formed Canadian Certification Committee within the Canadian Aquatic Resources Section (CARS) has recently undertaken a survey of post-secondary fisheries education in Canada. The objectives are to determine: the availability of formal education in fisheries sciences in Canada, the requirements for degrees and diplomas. and how these requirements and Canadian curricula compare with those in the U.S. The goal of this survey is to provide information for objectively defining criteria and standards for professional certification of AFS members graduating from Canadian institutions.

Early this year, questionnaires were sent to 63 degree-granting universities and colleges throughout Canada, including a French version the the appropriate institutions. A similar questionnaire was also sent to 138 diploma-granting colleges and technical institutes (similar to associate degrees in the U.S.). Information requested included: whether departments offered named degrees or majors in fisheries or aquatic sciences and at what levels, requirements for program completion, affiliations with other fisheries-related institutions where students could receive training for credit, and listings of fisheries and aquatic science courses available.

As of the end of February, the response has been good. Thirty-seven (59%) completed questionnaires have been received from universities and 36 (26%) from technical schools. Results will appear in *Fisheries*. The committee hopes that this effort will generate interest in CARS and the AFS in Canada. Contact Bruce Barton, 2736 Laurel Cres. SW, Calgary, Alberta, T3E 6B3.

# SOC ExComm Resolution to All Members

At the June 30/92 ExComm meeting it was resolved that:

- until guidelines have been adopted, no person will be permitted to attend any AFS/SOC sponsored classes, workshops, seminars and/or annual symposia unless applicable fees have been fully paid;
- 2) the Ways and Means Committee have been directed by the ExComm to develop guidelines for chapter sponsorship of individuals to classes, workshops, seminars and/or annual symposia where fees may be waived or funded by the Chapter, and further, to report such to the ExComm by Mid-September, 1992;
- 3) the Ethics and Professionalism Comittee have been directed by the ExComm to develop a policy/guideline statement concerning discrimination and harassment for all chapter members and functions.

Canadian educational institutes must initially be surveyed to determine the undergraduate and graduate degree requirements in the various fisheries and aquatic science programs. Secondly, the findings should be compared objectively with those requirements common the US colleges and universities, along with consideration of the marketability of graduates within both countries. finally, standards must be established for certification of AFS members graduating from Canadian institutes and/or employed in Canada.

The chair of this committee is Bruce Barton and the members are to be announced.

# CVCA Public Interest Group Meeting

A public interest group meeting was held on June 25, 1992 at the Credit Valley Conservation Authority offices to initiate a forum for discussion of common issues involving land use management in the Credit Valley watershed. The first meeting was aimed at finding common ground amoung various groups and to collectively decide on strategies for future sessions.
