NORTH CENTRAL DIVISION REPORT

Several members of the Southern Ontario Chapter were in attendance at the North Central Division (NCD) meeting and conference held in Detroit this past December.

At the NCD Executive Meeting I presented to the NCD Executive a proposal for the Chapter to become a member organization of the Conservation Council of Ontario and also to receive funding for the membership fee. This was passed with \$150 funding.

A special meeting was held to discuss recent concerns of the Canadian AFS constituents. Representatives from the NCD Executive Committee, Parent Society Governing Board, Southern Ontario Chapter, Northwestern Ontario Chapter, Mid-Canada Chapter, and the Canadian Aquatic Resources Section (CARS) were in attendance. The main concerns which arose during the meeting were that Canadian members were not getting much back out of their membership dues and that Canadian members should be united by a Canadian governing body. These issues were not resolved at the meeting; however, a couple of suggestions were put forward.

The first suggestion is to have all Canadian members become members of CARS which would act as a Canadian governing body. The second suggestion is to reconsider the idea of establishing a Canadian Division. The establishment of a Canadian Division would actually bring more of your membership dollars back into Canada!! The NCD Executive and the Parent Society Governing Board said that they are willing to get us rolling on either suggestion but they want us to do it or forget it. Hmmm, Quebec referendum déjà vu. The time is now!

PROFESSIONAL DEVELOPMENT SEMINARS AND WORKSHOPS: "SURVEY RESULTS"

The Southern Ontario Chapter of the American Fisheries Society is planning to offer an occasional series of seminars and workshops which are intended to provide opportunities for professional development, inter-disciplinary contact, and continuing education. The series is expected to focus primarily on fish and fisheries and other related aquatic-sciences topics. In an effort to determine the current areas of interest of Southern Ontario Chapter members, the previous newsletter (Volume 8, Number 1) included a survey sheet to obtain suggestions regarding potential program topics. Purpose:

The Meritorious Service Award recognizes "unswerving loyalty, dedication and meritorious service to the Society over a long period of time." It is awarded for "an exceptional commitment to the Society's programs, ideals, objectives and long-term goals."

Committee:

The President appoints a 5-member committee which seeks nominations or suggests nominees for the award. It is not essential that the award be given each year, but if a selection is made by the committee, the award is presented at the annual meeting. The committee should make the selection soon enough (by July 1) to prepare the award and to arrange for its presentation.

Schedule:

- April 15 - All award nominations and supporting data to Chairman.
- May 15 - System for evaluation and selections adopted. Names of nominees and supporting data distributed to all committee members.
- June 15 - Committee selection of proposed award recipient, if award is to be given.
- July 1 - Letter sent to AFS President and Executive Director, naming the award candidate and providing a supporting statement.
